



TACOMA BUSINESS LICENSE

WHO NEEDS A LICENSE?

Generally, any business that is operating or soliciting business in the corporate City limits or any person renting real property to others is required to be registered and licensed with Tacoma.

If a business is located outside of Tacoma and generates less than \$4,000 in annual gross income in Tacoma, no registration is required unless the business activity requires a regulatory license. For more information on specific business activities requiring regulation visit tacoma.gov/taxandlicense.

HOW MUCH DOES A LICENSE COST? License fees are based on your annual gross income and range from \$37—\$2,000. A full list of fees can be found at tacoma.gov/taxandlicense.

Gross Income is worldwide income generated from activity both inside and outside Tacoma regardless of the business location.

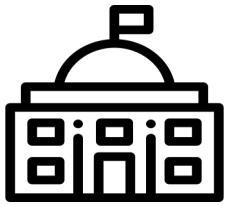


IS YOUR BUSINESS LOCATION IN TACOMA?
